Export Regulations

Export of night vision equipment and optical sighting equipment (including user manuals) is controlled by the U.S. Department of State Directorate of Defense Trade Controls, in accordance with the International Traffic in Arms Regulations (ITAR), Title 22, Code of Federal Regulations Part 120-130 and/or the U.S. Department of Commerce Bureau of Industry and Security in accordance with the Export Administration Regulations (EAR), Title 15, Code of Federal Regulations Part 730. Some of this equipment may require a license for export or reexport from the United States. Any export of equipment by ATN to a purchaser outside of the United States will be made in strict compliance with U.S. export control laws; **diversion contrary to U.S. law is prohibited.**

It is the purchaser's responsibility to request and obtain any required export licenses for the subsequent export or reexport of the subject items, and to ensure that the requirements of all applicable laws, regulations and administrative policies are met. In addition, subsequent transfers of any ATN products to individuals or entities on the List of Debarred Parties, Denied Persons list, Specially Designated Nationals List, Entity List, Unverified List or Nonproliferation Sanctions list, as well as sales or transfers to Embargoed Countries, are strictly prohibited. It is the purchaser's responsibility to be aware of these Lists, websites for which are attached to this form.

I understand that **all** of the products obtained from ATN Corp. are subject to one or more of the export control laws and regulations of the U.S. Government and that they fall under the control jurisdiction of either the Department of State or the Department of Commerce. I understand that it is unlawful to export or re-export, or to attempt to export or re-export, any of these products, for which a license or written approval of the U.S. Government is required, without first obtaining any license or written approval required from the Department of the U.S. Government having jurisdiction. I further understand that sales or transfers of any ATN products to individuals, entities and countries named in the lists referenced in the Attachment are strictly prohibited.
